Clarification on the terms of payment of the commission fee:

According to the Regulations for Organizing and Conducting an Electronic Auction for the Sale of Electricity on the Commodity Exchange - Ukrainian Energy Exchange Limited Liability Company and/or the Regulations for the Organization and Conduct of an Electronic Auction for the Purchase and Sale of Electricity under Bilateral Contracts in the Commercial Sections of the Commodity Exchange — Ukrainian Energy Exchange Limited Liability Company and/or the Regulations for the Organization and Conduct of Electronic Auctions for the purchase and sale of electricity under bilateral contracts using the technology of bilateral continuous auction on the commodity exchange Ukrainian Energy Exchange Limited Liability Company applies the same approach to the payment of the commission fee as defined for the Market Operator regarding the payment by market participants of the component costs of the Market Operator's services.

Thus, the commission fee of the Ukrainian Energy Exchange Limited Liability Company consists of the following components:

- 1) a fixed monthly payment for participation in auctions, amounting to UAH 1,322,58. (excluding VAT), paid by participants wishing to participate in the auctions on a monthly basis, in the form of full prepayment on the basis of an invoice issued by the Ukrainian Energy Exchange Limited Liability Company on the first business day of each calendar month, not exceeding 3 (three) banking days from the date of invoicing;
- 2) payment for purchase and / or sale transactions from participants who have concluded an agreement (agreements) in PP BETS, amounting to UAH 3,27 / MWh (excluding VAT)
- by the party of the auction certificate/agreement(s) to which the effects of the General Account apply in accordance with the provisions of the regulations specified in the first paragraph of this explanation by automatic debiting from the General Account of such party of the auction certificate/agreement(s);
- by other auction participants-parties of the auction certificate/agreement(s) on the basis of the auction Ukrainian Energy Exchange Limited Liability Company account within a period not exceeding 3 (three) banking days from the date of invoicing.

The amount of the commission fee is paid taking into account the value added tax on the basis of the relevant payment (settlement) document.

Non-residents of Ukraine pay an exchange (commission) fee in US dollars or Euros, depending on the currency of the trading session.
